1098-T Tax Information

1098-T Tax Information

All information needed for your 2011 taxes can be obtained via SeaNet and E-bill.

- **SeaNet** - provides your 1098-T statement amounts. If you did **not** receive your mailed 1098-T form you can find and print the information you need here. The 1098-T form does **not** need to be submitted with your taxes.
- **E-Bill** - provides the amounts paid to UNCW used for tax credit purposes.

Important Billing Information

Mid-Term bills were issued to collect any unpaid charges that may have occurred after the spring bill due date. The bills were issued March 1, 2012, and were due March 30, 2012. Student accounts with unpaid balances have a registration hold.

Graduating Students

1. Please pay your **E-bill** balance before you graduate. Failure to pay will result in a transcript and diploma hold.
2. You will **not** get a **2012** 1098-T tax form if:
 - a. You pre-registered for spring courses in November 2011 (charges are shown on the 2011 tax form).
 - b. You did not receive any scholarships and grants in 2012.

Note: Print your 2012 payment history in E-bill now for next year's tax purposes.

Summer I and II 2012 TealPay Plans

- Summer I and Summer II bills will be uploaded on Tuesday, May 1st (pre-registration opens April 9th).
- The Online TealPay 3 payment plan is available starting Wednesday, May 2, 2012.
- A down payment of 1/3 of the account balance plus the \$25.00 enrollment fee is due at sign up:
 - 1st installment due June 3rd
 - 2nd and final installment due July 3rd
- Summer I and Summer II TealPay enrollment closes on the bill due date May 23rd.
