Tuition Surcharges 2012-2013 Academic Year

Tuition surcharges are posted to student accounts when 140 hours are exceeded to complete a Bachelor's degree. The tuition surcharge rate is 50% for the 2012-2013 academic year.

The General Assembly amendment (*Section 9.10.(a) of Session Law 2009-451*) instituted the fifty percent (50%) tuition surcharge in 2010 and applies to all undergraduates seeking a baccalaureate degree.
