8 representing the best interest of the students of UNC Wilmington; and,

10 **WHEREAS,** The Campus Conduct System of UNC Wilmington has enjoyed proven success as
11 an educationally driven process that gives students the opportunity for a peer review of their
12 actions, and allows for self-reflection and development through educational sanctions reached by
13 a group of their peers; and,

15 **WHEREAS,** The Campus Conduct System has recently received scrutiny and faces potential
16 changes that would undermine the fundamental purpose of educating students on the importance
17 of sound decision making practices and has been encouraged to adopt a more punitive based
18 system; and,

21 recognized for the benefits of its educationally focused efforts in retained student enrollment;
