Degree Audit Update

As many of you know, UNCW has decided to change degree audit vendors. Effective January 4, we will begin the long and arduous task of implementing this new tool. We've had several demonstrations of its capabilities over the last year and we hope you've had a chance to see it. This project will take the better part of the spring semester to implement, so please bear with us as we hone our time management skills. We'll provide an update on our progress at the spring fora scheduled for early March. When we get to the testing phase and you're willing to help, let us know.

Current students under a catalog within the last 6 years will remain with the current degree audit system, U.achieve. New students entering under the fall 2016 catalog will use the new degree audit system, Degree Works. Of course, this all depends on meeting our late summer implementation plan. As catalogs expire, students will be migrating towards the new degree audit. This is the plan for now and is subject to a lot of variables. We hope this tool and its additional functionality will better meet your needs in future academic terms.
